## **OUWB Medical Library Staff**



Nancy Bulgarelli, Director Nancy Bulgarelli, MSLS, is the founding Library Director of the Oakland University William Beaumont School of Medicine Library. She has more than 25 years experience in the administration of medical libraries, with a focus on health sciences librarianship within large teaching hospitals. Prior to her appointment at OU, she served as Director of the Library and Archives at Henry Ford Hospital, the flag-ship hospital of a large, integrated health care system. Prior to that, she was Director of Library Services at William Beaumont Hospitals and Director of Library Services at Children's Hospital of Michigan.



Misa Mi, Associate Professor, Medical Librarian Misa Mi, MLIS, PhD, joined the faculty July 1, 2011 and is responsible for designing and developing library education programs and providing information services for medical students and faculty. Before joining the OUWB School of Medicine, she was a faculty member and medical librarian at the Mulford Health Sciences Library at the University of Toledo School of Medicine, serving as course director for an elective course and facilitator for PBL small group discussions. Prior to that, she was a senior information resource specialist at the Children's Hospital of Michigan, Detroit Medical Center. She is a certified senior member of the Academy of Health Information Professionals of the Medical Library Association.



**Stephanie Swanberg, Assistant Professor, Medical Librarian** Stephanie Swanberg, MSI, joined the faculty on June 15, 2011 as a recent graduate of the University of Michigan School of Information with a Master of Science in Information and an intern at the UM Taubman Health Sciences Libraries. At the OUWB Medical Library, Stephanie designs and instructs information mastery content for the Capstone curriculum and beyond as well as manages the library's reference, promotion and outreach activities.



Keith Engwall, Assistant Professor, Web & Emerging Technologies Librarian Keith Engwall, MS LIS joined the library faculty on July 1, 2012 and comes to us from Catawba College in Salisbury, NC, where he served as the head of library systems and technology. He received his MLS from the University of Illinois Graduate School of Library and Information Science in 1995. Keith intends to apply his 15+ years of experience in web design, programming, and technology research to create a dynamic mobile and online presence for the library and leverage new technologies to meet the needs of the Medical School and OU community.



She has previously worked at OU's Kresge Library in Technical Services as well as a stint at the Bon Secours Hospital Library. Shirley manages communication and organizational activities for the library, oversees the Medical Library Study Room, and is our frontline for medical reference questions.

# **Instruction & Course Development**

## **STUDENTS**

**NEW STUDENT ORIENTATION** Medical library faculty participated in Orientation Week for the charter class by developing an interactive one-hour library orientation. The orientation included a library scavenger hunt, brief presentations by Nancy Bulgarelli and Janet Zimmerman, Director of the Beaumont Health System Library, a hands-on activity on locating known citations using PubMed, and a brief evaluation. Student feedback gathered orientation evaluations revealed very positive results.

**CAPSTONE COURSE** As part of the Capstone course team, medical library faculty contributed heavily to the organization and development of the course. Capstone is a longitudinal curriculum aiming to help medical students build a solid foundation of knowledge and skills required for conducting scholarly work in a wide range of health-related disciplines including education, service learning, research training, and information mastery.

Medical library faculty developed five information mastery sessions from the ground up, including writing course and session objectives and creating teaching methodologies, learning activities, and assessments for each session. Information Mastery totaled eight hours in Capstone during the M1 year, accounting for 20% of the students' first semester and 15% of the students' second semester grades. Each session combines didactic lecture, demonstration, and active learning activities aimed at developing skills in the selection, searching, and basic evaluation of medical information resources. A pre- and post-instructional assessment tool developed by

Dr. Misa Mi was administered to students prior to and following their first year and will be used as one method of evaluating and evolving the curriculum for the future.

Integration of information mastery skills in the first-year medical student required curriculum was presented as a lightening round presentation and posters at the national, regional, and local levels including the Medical Library Association Annual Conference, Central Group on Educational Affairs Spring Meeting, and the Metropolitan Detroit Medical Library Group Spring Meeting.

**EVIDENCE BASED MEDICINE COURSE** In addition to the Capstone curriculum, medical library faculty are also part of the Evidence-Based Medicine course development team. The Evidence-Based Medicine course is a two-week course scheduled at the end of the medical students' second year. Course and session objectives were drafted by Dr. Misa Mi with three sessions dedicated to information mastery skills, including two sessions on evidence-based resources and another focusing on systematic reviews and meta-analyses.

**CURRICULUM INTEGRATION** Stephanie Swanberg participated in an interdisciplinary educational intervention in the Art & Practice of Medicine course in October 2011 dedicated to educating students on the influenza vaccine. The intervention, which included presentations by a Beaumont infectious disease physician, nursing staff, and medical librarian, instructed students on the importance of the flu vaccine to healthcare; demystified misnomers concerning the vaccine; and discussed effective methods on counseling patients on the flu vaccine. Stephanie specifically introduced students to various authoritative online health information resources for patients, including MedlinePlus, NIH Senior Health, and LactMed. The intervention was presented as posters and papers at several national, regional, and local conferences including the Association of Standardized Patient Educators Annual Conference, Central Group for Educational Affairs Spring Meeting, Michigan Academy of Arts, Science and Letters Annual Conference, and the Oakland University-University of Windsor Sixth Annual Conference on Teaching and Learning.

## **FACULTY**

**NEW FACULTY ORIENTATIONS** Medical library faculty conducted four one-on-one new faculty orientations to introduce OUWB faculty to the resources and services offered by the Medical Library. The orientations included tours of Medical Library spaces, introduction to the website and major medical information resources, and how to register for an interlibrary loan account.

**BROWN BAG SESSIONS** The Medical Library launched its lunchtime "Brown Bag" series of presentations in November 2011 after a survey of OUWB faculty was conducted to gather their input. These bi-monthly, one-hour faculty development sessions were designed to be informal and included brief presentations with significant time set aside for discussion and interaction. The series is open to all OU and Beaumont faculty and is promoted in the *Medical Library News*, the library web site, and in Oakland University's *Friday Faculty Announcements*.

**CONTINUING MEDICAL EDUCATION** In conjunction with the Continuing Medical Education Department at the Beaumont Health System and the OUWB Faculty Development Task Force, Dr. Misa Mi led the effort in creating an information mastery program for faculty development. The program consisted of a series of six lectures from January – June 2012 and was offered at each Beaumont Hospital location (Royal Oak, Troy, and Grosse Pointe) as well as on the Oakland University campus. William Beaumont Hospital designated these training activities for AMA PRA Category 1 Credit(s)<sup>TM</sup> and therefore provided an incentive for both OUWB clinical faculty and physicians to attend the sessions and receive continuing medical education credit. Dr. Mi developed objectives and descriptions for each lecture with library faculty developing content, handouts, and activities for their respective sessions.

Over the series, a total of 127 people participated across the four locations including OUWB faculty, Beaumont physicians, residents, librarians, and Beaumont staff. Participation was especially high at Royal Oak (n=93) and Troy (n=22), but small at the Grosse Pointe (n=7) and Oakland University (n=5) locations. 'Introduction to Evidence-Based Medicine' and 'Searching PubMed for the Best Evidence' yielded by far the highest interest and participation in the series with a total of 89 participants between the two sessions. In addition, 65 of 127 (51.2%) total participants applied for and received CME credit. All sessions in the series required participants to apply for their credit via the new online system implemented by the Beaumont CME Office.

Based on evaluation data collected from the Beaumont Continuing Medical Education Office, the series has received phenomenal feedback with participants remarking of the applicability of the sessions to their clinical practice and scholarly pursuits.

"Better understanding of copyright law as it pertains to education and research at my institution"

"Will be using the RefWorks product to create bibliographic reference for publication"

**FACULTY LEARNING COMMUNITY** Dr. Misa Mi applied for and received a \$1,500 grant from the Oakland University Provost to create a faculty learning community on medical education research focusing on scholarly teaching and scholarship of teaching. Dr. Mi scheduled a yearlong educational program with different types of learning activities including seminars, workshops, and research forums. The opening retreat occurred on February 2, 2012 and featured a presentation on alternative research methods by Eileen S. Johnson, PhD, Associate Professor, School of Education and Human Services, Oakland University. 
- **February 3**: The Faculty Learning Community kicked off its year-long education program with an opening retreat. Dr. Eileen Johnson from the School of Education and Human Services was the invited speaker to present on the topic *Alternative Approaches and Methods to Educational Research*.
- **February 10**: Misa Mi, PhD, facilitated a small group discussion session on the topic *Scholarly Teaching* and *Scholarship of Teaching and Learning*.
- March 9: Jennifer Eastwood, PhD, Misa Mi, PhD, presented on the topic *How Students Learn and Implications for Teaching*.
- March 23: Jill Stefaniak, MTD, CPLP, was invited to present a seminar on Learner Needs Assessment.
- April 4: Misa Mi, PhD, facilitated the first Research Forum event. Participants were invited to share and discuss opportunities for collaborative research and teaching projects.
- May 4: William Solomonson, PhD, presented a talk on *Teaching Online/Blended Learning*. Dr. Solomonson is an Assistant Professor from the Department of Human Resources and Development, School of Education and Human Services, Oakland University.
- May 25: Constance Shriner, PhD, presented on Writing Effective Multiple Choice Items. Dr. Shriner is an Associate Professor, Associate Dean of Curriculum Evaluation & Faculty Development, University of Toledo School of Medicine.


# Reference

During the past year, the Medical Library recorded 380 total patron encounters touching 986 people and clocking 133.69 hours on instruction, reference, research consultations and literature searches. Reference accounted for the highest number of requests, but instruction dominated in participants and hours accounting for 68% of our total hours.

Email (n=173) was the most common method of contact with in-person requests close behind (n=154). A majority of requests (82%) originated from OUWB administration faculty, students, and staff and 13% from Oakland University faculty, students, and staff.

**ACQUISITIONS PROCESS IMPROVEMENT PROJECT** With the support and assistance of the Kresge Library Technical Services Department, the Medical Library initiated a process improvement project to reduce the turnaround time for acquiring and cataloging new materials. A key component of the process is the use of "shelf-ready" books from our major vendor, Yankee Book Peddler. A yearlong pilot has been designed using the Plan-Do-Study-Act model by Shewhart / Deming as a framework.

**LIBRARY LIAISON PROGRAM** The library formalized its liaison program with each library faculty member assuming responsibility for specific courses and disciplines. Liaison responsibilities include collection development, course guide creation, and faculty support. During the M2 Semester, the library acquired additional materials to support the Neuroscience, Cardiovascular and Respiratory courses and developed the following course pages using SubjectsPlus:

## **EXHIBITS & EVENTS**

**National Women in Medicine Month** To celebrate Women in Medicine Month, the OUWB School of Medicine, Medical Library, and the American Medical Women's Association (AMWA) student chapter collaborated to host a series of events honoring women in medicine.

Throughout the month of August, the library hosted the National Library of Medicine exhibit "Changing the Face of Medicine: Celebrating America's Women Physicians." As one of 61 stops on its tour, the exhibit highlighted the stories of women who have influenced and practiced medicine in our country's history.

The exhibit moved to Beaumont in early September to coordinate with the hosting of the play "A Lady Alone — Elizabeth Blackwell: First American Woman Doctor" featuring Linda Gray Kelley. Miss Kelley captured the eyes and ears of the nearly 100 guests at the event with her passionate portrayal of the trials and successes of Elizabeth Blackwell on her road to becoming America's first female physician. Students, faculty, and staff of the OUWB and Beaumont gathered to enjoy the event.

"The Immortal Life of Henrietta Lacks" Book Discussion On October 19th, OUWB Diversity & Multicultural Affairs and the library partnered to host a presentation and discussion of *The Immortal Life of Henrietta Lacks* by Rebecca Skloot, which chronicles the story of the woman behind the HeLa cell line and her everlasting impact on science and medicine. During Henrietta's fight with cervical cancer, her physicians took her cells without her knowledge. Participants in the event had the opportunity to discuss medical research protocol and standards, medical ethics, informed consent, and patient rights from the time of Henrietta in the 1950s to the present. The discussion proved a very lively one, bringing together the opinions and perspectives of OUWB-affiliated faculty, physicians, & staff, Kresge Library faculty and staff, as well as representatives of other university offices, such as the Grants Office.
