It was their hard work that ensured the continued smooth operation of the Medical Library.

# **Instruction & Course Development**

### **STUDENTS**

**NEW STUDENT ORIENTATION** Library orientation was modified to accommodate the increased class size and to respond to feedback on evaluations from previous years. It featured a large group presentation with all students, handouts and optional library tour. The group presentation included an introduction to the concept of information mastery, a virtual tour of the web site focusing on those portions of immediate use to students, and an overview of services and resources. Much to our surprise, all 125 students elected to go on the optional tour! This reinforced students' high interest in the study spaces and resources available to them and will be taken into account when we plan next year's orientation.

**M1 CAPSTONE COURSE** Information Mastery sessions in the M1 Capstone course did not significantly change for this academic year with 7 sessions totaling about 7 hours of instruction in 2015 /2016. The sessions are outlined in Table 1. Course and session objectives, teaching methodologies, learning activities, and assessments for each session were revisited and updated. Each session combined didactic lecture, demonstration, and active learning activities aimed at developing skills in the selection, searching, and basic evaluation of medical information resources.

**Embedded Librarian Office Hours** In anticipation of the M1 Capstone proposal due date in early January, the Medical Library piloted hosting a research consultation table outside of the student lounge on November 30 and December 2, 2015, from 11:00am – 1:00pm each day. Library faculty answered student questions on the spot and set-up appointments with others who needed more in-depth consultations. If repeated, the library would choose a different time of the semester as the last week before final exams proved challenging.

**M2 CAPSTONE COURSE** The M2 Capstone course welcomed a new course director this year, and Medical Library faculty expanded their instruction time in this course by leading the series of sessions on presenting and publishing scholarly research. Table 2 outlines library faculty contributions to the course:

In addition to the M1 and M2 Capstone courses, Keith Engwall, Misa Mi, and Stephanie Swanberg served as judges for the M2 Capstone Oral Presentations in March and the finalist presentations in May. Keith Engwall also served as a reviewer for the M3 Capstone Mini-Manuscripts.

**INTEGRATIVE EVIDENCE BASED MEDICINE COURSE** Medical Library faculty continued their roles as members of the Evidence-Based Medicine course development team. The Evidence-Based Medicine course completed its fourth iteration in winter 2016, running May 23 – June 6, 2016. Library faculty were involved in course planning and development and taught three sessions, accounting for 6.5 instructional hours (see Table 3).

For the second year, student case presentations were used to assess students' skills in locating, appraising, and applying current research evidence to a clinical case. Specifically, information search and synthesis skills were included as items on the presentation judging rubric. Nancy Bulgarelli, Misa Mi, and Stephanie Swanberg served as judges of the EBM case presentations on June 1 and June 2, and all library faculty collaborated on completing the non-cognitive evaluations of each student with other members of the course team on June 13, 2016.

#### ADDITIONAL CURRICULUM INTEGRATION

**Art & Practice of Medicine Course** On October 22, Stephanie Swanberg presented a 30-minute session on patient education as part of the annual flu vaccine clinic for the M1 Students, which immediately followed the presentation on myths and facts of the flu and flu vaccine by an infectious disease physician. The session combined lecture and hands-on searching of MedlinePlus. A new roleplaying activity had students break into pairs and discuss how to approach patients who come to the doctor's office with health information in hand. This activity directly connected with scenarios the students would encounter with a standardized patient later in the semester in the APM course.

**Promotion and Maintenance of Health Course** Keith Engwall, Dr. Misa Mi, and Stephanie Swanberg served as small group facilitators again this year for the course's two journal clubs on childhood obesity on February 26 and cardiovascular screening for youth athletes on April 14. For each journal club, Stephanie Swanberg also graded 125 student journal club assignments with the course director, Dr. Victoria Lucia.

**ONLINE INFORMATION MASTERY CURRICULUM** A 10-module online information mastery curriculum that was developed by Dr. Mi can now be accessed via e-Space. It encompasses 32 video tutorials, handouts, web resources, assignments, and other learning resources. The goal of the curriculum is to develop and enhance students' information literacy competence for lifelong learning as future physicians. It complements and supplements what is taught in the limited contact hours allotted to library instruction in the medical curriculum.

**STUDENT INFOBITE SERIES** For the fourth year, the Medical Library hosted our lunch series for students to complement the content taught in the Information Mastery curriculum and to introduce new concepts that are currently not taught elsewhere. Sessions continued to be held in O'Dowd Hall with lunch provided to attendees. Attendance over the five sessions totaled 135 students, a significant increase from the previous three years.

### FACULTY

**NEW FACULTY ORIENTATIONS** The Medical Library introduced the School of Medicine's newest faculty to our resources and services this academic year and completed a total of 2 new faculty orientations. Faculty toured Medical Library spaces and website, were provided with an overview of the library's liaison program and resources available in their disciplines, and were apprised of the collaboration opportunities for courses and scholarly activities with library faculty.

**FACULTY BROWN BAG SERIES** The Medical Library continued its faculty development series on Oakland's campus targeting Department of Biomedical Sciences faculty. This monthly series of informal lunch-time sessions focused on various topics in information mastery and medical education scholarship. A total of 60 participants were recorded in attendance over the 6 sessions including OUWB faculty as well as some staff and administration. Several sessions were offered to remote participants via Webex.


**OU Libraries Scholarly Communications Series** Stephanie Swanberg led a faculty/graduate student development session on Open Data on March 24, 2016, as part of OU Libraries Scholarly Communications Series. The session reviewed trends in the open data movement, resources for locating existing data sets, as well as showcasing a new form of publishing data as scholarly activity through data journals. The session was one of a three-part series to raise awareness of scholarly publishing topics including impact metrics, copyright, and authors' rights.

### Reference

In the 2015/2016 academic year, the Medical Library continued to be of assistance to Oakland University William Beaumont School of Medicine and the community. This included a total of 569 recorded patron encounters, encompassing 624.88 hours of reference, research consultations, instruction and community engagement. The Medical Library worked with 2,986 patrons; 45% of these encounters were in person and 42% were via email. The majority of these encounters were with medical students. For more detailed information on the breakdown of these encounters see Table 6 below.

# Collections

The library continued to add to its electronic collections based on user requests, curricular changes, and other needs assessments. Table 7 showcases our major new acquisitions. We are particularly excited about two of the newest databases – *AccessMedicine Case Files* and *LWW Health Library: Clerkship* – because they contain resources of high relevance to the clerkships and fill identified gaps. We will be promoting these resources at the M3/M4 Curriculum Subcommittee Meetings. *The Oxford University Press Journal Archive Package* is a one-time purchase of ejournal backfiles that fills a significant gap in our journal collection as identified by interlibrary loan activity.

Table 8 displays the number of downloads from our major resources for the year and the percentage change in usage from the previous year.

The 2015/2016 year continued to show an increased trend in use of library resources. As Table 8 above shows, most of our major electronic resources showed a slight uptick in usage. Notable exceptions include *AccessMedicine*, which dropped due to changes in required textbooks, along with *New England Journal of Medicine* which had 21% drop in usage compared to the previous year. Overall, the Medical Library measured a total of 115,641 ejournal article downloads, and 37,908 ebook chapter downloads. *UpToDate* remained our most frequently used resource with 42,528 topic downloads. ### **PRINT COLLECTION**

While the vast majority of the Medical Library's collection is electronic, we do maintain multiple print copies of all the required and recommended course textbooks in the Quite Study room. We also have an extensive collection of print review books and study guides, and purchase print books when an electronic version is not available or when print is specifically requested by a faculty member.

In 2015/2016, the library added 170 print books to its collection at a cost of \$12,707.24.

Our students – despite being "digital natives" – appreciate and use these print materials. Over the course of the 2015/2016 period, we recorded re-shelving a total of 2,744 items.

### **INTERLIBRARY LOAN & DOCUMENT DELIVERY**



### Website

#### SITE USAGE

In the 2015/2016 year, the Medical Library web site had a total of 57,517 page views.



The site received heaviest usage in October and November, with a dip in December and then fairly steady usage during the Winter semester.

Site usage is broken down as follows:

- Nearly half of users were able to locate what they were looking for directly from the home page which received 26,742 page views. The expectation is that most users are searching PubMed and are linking to it from the home page.
- 18% of users visited the databases page.
- 15% used one of the books pages, including the M1, M2, and Clerkship Textbook lists.

A new website section was created for providing access to the quarterly and annual library reports and faculty publication lists.

#### WEBSITE PROJECTS

There were several key projects completed on the back end of the web site, following the successful migration of the site to a new set of campus servers in the 2014-2015 year. The following is a sampling of the projects completed.

#### New site editing workflow

In 2014/2015, the medical library shifted from a template-based structure using Adobe Dreamweaver to a more flexible structure based on PHP. During this time, a new workflow for web authoring and version control using git repositories was investigated and tested. In July of 2015, the new git infrastructure was implemented, allowing authors to check out branches of the web site on their local computers, make changes, test them, and then merge their changes to the production site. In 2015/2016, there were 425 changes made to the website through git.

#### **Code modularization**

One of the benefits of the website's new PHP-based structure is that the site can be modularized. Common page components, such as the navigation sidebar, can be stored in a separate file that is pulled in by each page. This allows for easier site maintenance and more efficient performance. In the 2015/2016 year, most of the code for the site was revised to modularize site components and functions.

#### **Standards Compliance**


During the recoding of the medical library website, the PHP code for the whole site was brought into compliance with PHP Standards Recommendations (PSR) to reduce the chances of site errors and improve ongoing maintenance and troubleshooting. HTML was brought into compliance with HTML5 standards.

#### **Database Update**

In July – August, the database for the Medical Library website was updated from MySQLi to PDO. This required re-coding of all database calls in the website code.

# **Medical Library Study Space**

Although we are not used to thinking about space as a service, the provision of spaces that support students' different study needs is an important role of the Medical Library. The Medical Library provides space for individual quiet (i.e. silent) study, small group study, and larger collaborative study. Library space on the OU campus is used mainly by M1 and M2 students, but a few M3 (.69%) and M4 (.35%) do continue use the spaces.



# **Community Engagement & Outreach**

### **EVENTS**

The Medical Library continued hosting our most successful events as well as our participation in several OUWB-sponsored community service initiatives. The following highlights our activities.

**Medical Library Open House** The Medical Library hosted its second Annual Open House on September 16, 2015. Designed to bring people to the Medical Library spaces, it provided an opportunity for students, faculty and staff to meet and mingle in an informal setting and to introduce (or re-introduce) them to the resources available. Articles written by OUWB students were displayed, showcasing the school's scholarly activity.

**4th Annual Organ & Bone Marrow Donor Registration Drive** (October 6 – 8, 2015) Stephanie Swanberg coordinated this event at OUWB as part of Michigan Libraries for Life, the statewide initiative started at the

University of Michigan in 2010 to raise awareness of organ donor registration on college campuses. The library partnered again this year to host a dual drive to include bone marrow donor registration with two student groups – OUWB Student National Medical Association (SNMA) and the OU Minority Association of Pre-Medical Students (MAPS) – along with OUWB Diversity & Inclusion. The drive was hosted for 12 hours over three days with 45 volunteers who spoke with 242 people and registered 23 new organ donors and 48 new bone marrow donors.



#### 3rd Annual Gaming Fundraiser for Beaumont Children's Hospital On October

14, 2015, Keith Engwall co-hosted the third annual gaming fundraiser with medical students' Pediatrics Interest Group to raise money for Beaumont Children's Hospital. The fundraiser was held in the OUWB Student Lounge from 4:30pm until 9:00pm, and featured a variety of board and video games. Although attendance was slightly lower than the previous year, those who attended were very engaged and had a great time. The fundraiser raised \$150 for the Children's Hospital.

**3<sup>rd</sup> Annual Open Access Week** (October 19 – 23, 2015) For the third year, Stephanie Swanberg planned and coordinated Open Access Week activities on OU's campus with Julia Rodriguez, Health Sciences, Nursing, and Faculty Research Support Librarian at OU Libraries. Two educational events were sponsored with 13 total faculty attending:

- October 19 Open Data: Locating & Sharing Research Data to Promote Global Scholarly Communication brown bag workshop presented by Stephanie Swanberg
- October 23 *Getting Cited: Increase Your Impact with Open Access* brown bag workshop presented by Julia Rodriguez

Harvest of Health Fest at Avondale High School On October 23, 2015, Misa Mi and Stephanie Swanberg promoted easy-to-read, quality health information through the National Library of Medicine's MedlinePlus website as well as distributing informational handouts on common diseases and conditions as part of the OUWB's Harvest of Health Rest at Avondale High School in Auburn Hills.

**Martin Luther King Day of Service** On January 16, 2016, Nancy Bulgarelli, Keith Engwall and Stephanie Swanberg promoted easy-to-read, quality health information through the National Library of Medicine's MedlinePlus website as well as informational handouts on common diseases and conditions as part of the OUWB's Community Health Fair at Chandler Park Academy in Harper Woods. The library continued our "print on-demand" service using a mobile printer to print quality health information for community members on their topics of interest right at the table.

**Bioengineering Biomedical Sciences Summer Program** During the last week of June, Keith Engwall participated as the embedded librarian and webmaster for a summer STEM program hosted by OUWB and the School of Engineering. The Bioengineering Biomedical Sciences Summer Program, in its fifth year, provided approximately 30 high school students with nine days of medical and engineering sessions covering such topics as infectious disease, kinematics, and immunobiotechnology.

Over the course of the 9-day program, students conducted group research projects culminating in the formal presentation of a scholarly infographic during on the final day. Keith created the program's website and provided research assistance and also led an information literacy session on June 20. New this year, Keith, Stephanie Swanberg, and Monica Muresan, Instructional Technology Specialist at the OUWB Center for Excellence in Medical Education, led a new session on 'Perfecting Your Presentation Skills' on June 23. This one-hour session demonstrated the "dos and don'ts" of creating and giving oral presentations and gave students time to practice their own presentations as a group.

**Diversity Dialogues** The Medical Library continued its co-sponsorship of the Diversity Dialogue series developed by the Diversity Programming Team to raise awareness of issues of diversity in health, work, and the academic environment. The team includes Stephanie Swanberg, Caryn-Reed Hendon and Kimberly Martin of OUWB Diversity & Inclusion, Stephanie Jurva of OUWB Student Affairs, and student representatives. The team hosted the following events this year:

- How Race Impacts the Management of Chronic Disease On September 29, 2015, the Diversity
  Programming Team invited Dr. Linda Hunt, Professor in the Department of Anthropology at Michigan
  State University, to speak on her NIH-funded project focusing on how clinicians think about racial
  difference, and how their understanding of race affects their provided care. The Medical Library cosponsored this Diversity Dialogue as part of the Diversity Programming Team's annual offerings.
- Faith in Medicine Panel On November 17, 2015, the Medical Library co-sponsored this Diversity Dialogue featuring a panel of four physicians and one representative from a community faith-based organization to discuss balancing spirituality and medicine. The following faiths were represented on the panel: Islam, Sikhism, Christianity, including The Church of Jesus Christ of Latter-day Saints, and Scientology. This is the third time the team has sponsored such a panel to raise awareness of how physicians approach their own spirituality in their practice and that of their patients.
- National Wear Red Day 2016 On February 5, 2016, the team encouraged all OUWB to wear red in support of women's heart health.

**Women in Medicine Month Celebration** Stephanie Swanberg collaborated with the OUWB Group on Women in Medicine (GWIMS) to coordinate two events featuring Dr. Linda Pololi in celebration of Women in Medicine month:


#### **EXHIBITS**

# **Other Initiatives & Activities**

### **OPEN ACCESS GRANT PROGRAM**

With the three-fold goals of providing additional venues for faculty publication, enhancing the visibility of faculty research, and education faculty about OA journals as an alternative publication model, the Medical Library established a small fund to cover the author fees associated with these journals. In order to be eligible, the journals must meet strict criteria including having peer review and being indexed in by PubMed, Scopus or Web of Science. Two faculty members submitted grant applications and received funding for their publications.

### **OUWB Publications List**

This ongoing project recognizes the School of Medicine's scholarly activity by tracking the journal articles, meeting abstracts, book chapters, books and other works written by OUWB faculty, students and staff. Reports are created by searching the institutional affiliation fields in PubMed, Scopus, Web of Science, EMBase, Google Scholar and Google books. In addition, some highly prolific authors are searched by name. Members of the faculty are also asked to submit difficult-to-locate items such as books and book chapters for inclusion. Citations are downloaded to an EndNote database and enhanced with information about the authors' OUWB departments and status. The citations of these works are used in five reports throughout the year.

Each quarter, the Medical Library circulates a report of citations that were located with the above mentioned process. In 2016, the combined count of citations for the January-March quarter and April-June quarter was 355. These included 219 articles, 15 books and book chapters, and 4 MedEdPortal publications. In addition, 37 of the publications were produced by OUWB students.

Once a year the library also produces an annual compilation of all faculty publications. In an attempt to make this report as comprehensive as possible, we compare all the citations collected over the year with those identified in the Beaumont Research Institute's yearly report, and include any that our automated process overlooked. This comparison will soon be conducted for 2015 as the Beaumont Research Institute's yearly report was just published in September 2016. In the meantime, there is a breakdown of the citations we identified in 2015 located in Appendix 4. This breakdown includes publication totals by department as well as publication type.

In addition, a new webpage on the Medical Library website was created, making these publication reports available to the public at <a href="https://medlib.oakland.edu/about/publication\_lists.php">https://medlib.oakland.edu/about/publication\_lists.php</a>. The web page includes all the annual and quarterly reports the Medical Library has compiled to date. We hope this new accessibility will increase visibility of the OUWB's research.
