In recognition of their leadership and active participation in the affairs of the University, a former member of the Board of Trustees who served no less than four consecutive years of the member's expired appointment will become a Trustee Emeritus.

Trustee Emeritus rank will carry with it all the privileges extended by the Board of Trustees to those Trustees whose terms have not yet expired and are currently serving.

Trustee Emeriti will maintain such rank at the pleasure of the Board of Trustees, and additional privileges may be conferred by the Board of Trustees from time-to-time at its discretion.

Trustee Richard A. Flynn, seconded by Trustee Michael R. Kramer, moved approval of the Consent Agenda and the motion was unanimously approved by those present.

D. New Items for Consideration/Action

Appointment of Board Chair and Vice Chair

Trustee Kramer presented the Board of Trustees Ad Hoc Nominating Committee's recommendation for the Appointment of Board Chair and Vice Chair as set forth in the agendum item.

RESOLVED, that the Board of Trustees Ad Hoc Nominating Committee recommends approval of the appointment of Trustee Mark E. Schlusel to a second one-year term as Chair of the Board of Trustees; and, be it further

RESOLVED, that the Board of Trustees Ad Hoc Nominating Committee recommends approval of the appointment of Trustee Richard L. DeVore to a second one-year term as Vice Chair of the Board of Trustees.

Trustee Kramer indicated that the Nominating Committee consisted of Trustees Tull, Stolicker and Kramer. Nominations were had and those nominated for another year term were Trustee Schlusel as Chair and Trustee DeVore as Vice Chair. The Committee voted and it was unanimously confirmed that Trustee Schlusel shall be Chair for the coming year and that Trustee DeVore would be Vice Chair.

After discussion, Trustee Kramer, seconded by Trustee Melissa Stolicker, moved approval of the recommendation, and the motion was unanimously approved by those present.

Chair Schlusel stated that being Chair of the Board has been a wonderful experience and that Oakland is a remarkable university, it is a privilege to serve, and the Board should be proud of what has been accomplished. Oakland has great students, extraordinary faculty, a terrific administration and Oakland has done remarkable things locally, regionally, and nationally.

E. President's Report

President Hynd began his report by reviewing what has been accomplished in the past year. Upon arriving on August 16, 2014, he began several 30-day plans which included a media blitz, legislative visits, and he began connecting with alumni and community supporters. Subsequently, a new strategic plan was approved, first by the University Senate and then by the Board of Trustees. Strategic plan committees have been formed to make sure the strategic planning process moves forward and school and college level strategic plans have been developed. Leadership changes have occurred and include establishing a Vice President for Communications and Marketing, Vice President of Organizational Development and Strategic Planning, and Vice President of Student Affairs. A Graduate Studies Dean, a new Dean of the School of Education and Human Services and Dean of Libraries have been hired. A communication plan has been developed which includes reports at each Board of Trustees formal meetings and reporting to faculty and staff twice each semester. The marketing and communications plan has been reviewed and revised. Meetings with each school and college except one have been accomplished and the School of Medicine has been accredited by the Liaison Committee on Medical Education. Oakland won the McCafferty Trophy for having the overall most successful Horizon League athletic teams. Through a planning process, a 2016 fiscal budget has been developed that is carefully linked to the strategic plan which has been passed by the Board which will enhance Oakland's academic prowess and excellence. Research and IT infrastructure and faculty and staff needs will be addressed to better serve our students.

Moving forward, President Hynd indicated he will be more externally oriented working with the deans and other leaders on campus to advance Oakland's strategic objectives and he will have anniversary visits with local media and legislative visits. He will visit 12 cities within 18 months to connect to alumni. School and college level strategic plans will be finalized as will dashboard metrics. Consultants have been engaged to look at the Development and Alumni Relations organization prior to launching a public campaign for Oakland University and a Campaign Steering Committee will be established. Development of tier 2 and 3 supporters will be a priority. Searches for the Vice President for Development and Alumni Relations, Dean of Nursing and Dean of Health Sciences will be conducted. Finally a communication plan to track progress in achieving the priorities noted in the 2016 budget will be developed.

F. Dean's Report

Dean Folberg began his report by indicating that he was named Founding Dean on July 31, 2008 and around that time the Josiah Macy Jr. Foundation, which sponsors research in medical education, met with all of the universities who were forming new medical schools. They were told that if their new medical schools look like an existing legacy medical schools, they would be considered failures. Thus, when Oakland began to design the Oakland University William Beaumont School of Medicine (OUWB) the intention was to develop something for Oakland University that would evolve into a medical education masterpiece.

Unlike general higher education institutions, there are only two types of medical schools around and those are the large research medical schools and community based medical schools. Oakland wanted to design a medical school that was neither of these two types and the background for this is a document that came out in 2007 from the American Medical Association called the "Initiative to Transform Medical Education" in which it was said that "the emphasis on medical students acquiring knowledge and problem solving may lead physicians to perceive patients as simply sources of data and problems to be solved instead of individuals in need". During his interview process, a Beaumont physician asked him during the interview "Look, I know that you can train a doctor to be academically brilliant. I want to know how you intend to train a physician to be kind?" The answer to that question is the OUWB. This is accomplished by the selection of our students, the immersion into a learning environment that is special, the curriculum which guides them through their medical studies, and engagement with the community. OUWB became the first beta site for the Association of American Medical Colleges holistic admissions review process which looks for experiences and attributes that predict a high level of empathy, compassion and engagement. Dean Folberg described the demographics of OUWB's students and their diversity in terms of where they come from, languages spoken, where they obtained their undergraduate education, and even their undergraduate majors.

The OUWB curriculum is different than other medical schools and many new medical schools have begun to imitate OUWB. In addition to learning the basic sciences and the basic sciences as they apply in a clinical sense to each of the organ system based

courses, OUWB has something that is special as it has five courses that span multiple years of the curriculum. There is a beautiful clinical skill center constructed at Beaumont Troy where OUWB students actually practice before they ever encounter a patient with actresses and actors who simulate patients. OUWB students are engaged in humanities every year that they are in medical school. OUWB students spend four years under the guidance of ethics faculty. Finally, there is Prism, promoting reflection and individual growth through support and mentoring. It involves self-development, personal-development, wellness so that you practice this throughout your life because you need to be whole yourself before you can treat others. Capstone is a required program for each of our students. It is a program by which they spend four years conducting a research project.

OUWB is engaged in the community. Compass has 50 community partners. Dean Folberg then highlighted the accomplishments of several OUWB students. He noted that OUWB is a bit different because at OUWB the students are expected to attend class and not stream videos at home which allows them to learn from each other and "live" diversity.

He made note of a Detroit News article in which, Dr. Carol Aschenbrenner, chief medical education officer of the Association of American Medical Colleges, said that OUWB's approach to training doctors goes beyond a personal approach and stated "a lot of schools have something similar in their curriculum to help develop physicians as people, but nothing to this degree that OUWB has. The approach is more holistic, focusing on the treatment side of the whole person, rather than just the physical symptoms of disease".
